Decision will be announced on or before December 31<sup>st</sup>, 2006 via e-mail to all applicants and posted on the Top Sound Productions website. All applications will be judged based on the quality of lyrics, melody, and groove of the songs. Winning applicants may use studio time prizes towards use of any of Top Sound Productions mobile and in-house recording, mixing and mastering studio services. Mobile recording services are limited to a 50 mile radius of Raleigh NC. All studio time services are by appointment only and must be used by December 31<sup>st</sup>, 2007. All judgements and decisions made by the contest judge(s) and Top Sound Productions are final. All other rights are reserved. Entry fee is non-refundable.
